**PERFORMANCE DRIVING CAN BE DANGEROUS AND MAY INVOLVE INJURY OR DEATH**

You must read and sign the following declaration as a condition of your participation in this track day at the Venue.

**In consideration for being permitted to participate in this track day by Lotus on Track Limited (Hereinafter known as – LoT) I accept, agree and confirm that:**

1. I am familiar with the nature of the activity I wish to undertake and accept that, despite LoT taking all reasonable precautions, damage or injury may occur. I accept these risks and take part in the activity at my own risk.
2. I am competent to take part, I am not taking any drugs (whether prescribed or otherwise) that may impair my ability to take part and I do not suffer from, and have no history of, any medical condition that could affect my ability to take part in this event. I am fit and healthy and that my eyesight (with lenses if to be worn) is adequate for track use, I do not suffer from colour blindness.
3. I am not under the influence of alcohol.
4. I do not have anxiety, panic attacks or post-traumatic stress disorder and have neither needed to see a doctor nor needed any treatment for any of these in the last 2 years. I have never been diagnosed as having psychosis, schizophrenia, manic-depressive psychosis, bipolar disease or any other serious mental illness.
5. I will satisfy myself (by sighting lap or otherwise) before taking part in any on track activity that the track is acceptable to me with regard to its features, it's condition and its physical layout. I will not carry a passenger until I have completed at least 3 familiarisation laps.
6. I have read and understood, and will comply with, all information and regulations provided to me in relation to the track day and I will comply with instructions and directions given by the organisers, instructors and any other representative of LoT at all times whilst at the Venue. In the interests of safety, the organisers or instructors may exclude me from further participation in the activity if they think I am driving recklessly or dangerously. I am aware that other participants will be on the track at the same time as me.
7. I hold a full valid road driving licence appropriate for the vehicle I intend to drive on track. I understand that I must show this at sign on.
8. The vehicle I intend to use is fit to use on this track day. In particular it is safe and roadworthy. It complies with any relevant regulations (including without limitation relevant track regulations) and is fit to use for the purpose(s) for which I have attended the venue. Any in-car camera or other equipment is safely and securely attached, using mounting systems specifically designed for that purpose.
9. I understand that LoT's insurance does not cover damage to my vehicle at the Venue (whether caused by me or anyone else driving it, or caused by another participant), and that LoT recommends that participants procure their own track day insurance. The use of my vehicle is entirely at my risk and I accept responsibility for any damage to my vehicle howsoever caused. LoT will not be scrutineering participant's vehicles before permitting them on the track, nor has it any control over the level of competence of other participants.
10. I shall wear a seat belt or properly fitted harness at all times whilst in a vehicle. I shall wear a properly fastened approved crash helmet that is suitable for use in a car on a circuit at all times whilst on the circuit. I understand that timing is not permitted.
11. I understand that I will be liable to any charges brought by the circuit or it's agent for damage caused by myself as a result of any accident.
12. LoT may take photographs and/or video footage of me during this event and may use such photographs or footage (including my likeness and image) for future promotional, marketing and publicity purposes in any media worldwide without notice or payment.
13. I agree that any material filmed or recorded by me at the Venue is for personal use only and is not for broadcast (whether for commercial reasons or otherwise) on any public transmission media anywhere in the world (including on the internet, e.g. on Facebook or YouTube).
14. I agree to make no claim against LoT, its employees, instructors or any company or organisation connected with the event in respect of any loss or injury suffered by me during a track event, and to indemnify them against their costs and losses arising out of any claim made against them by anyone to the extent that such costs and losses are attributable directly or indirectly to my participation in a track day.
15. I understand that it is a condition of my participation in the activity, or activities, in which I intend to take part that in the event of accident, loss or damage occurring during such activity or activities that neither I nor my agent/insurer will pursue any claim for damages against any other participant (save in respect of injury or death). Under the provisions of the Unfair Contract Terms Act 1977 it is not possible to exclude potential liability for injury or death.

**I have read and agree with the above declaration and indemnity, along with Lotus on Track Ltd terms and conditions and agree that it's terms will also apply to my participation in any future track day organised by Lotus on Track Ltd, unless I sign a subsequent declaration and indemnity, which will then take precedence.**
